





### SUBJECT: ADHERENCE TO THE GENEVA CONVENTION AND PROTOCOLS

Considering that the Movimentu de Liberatzioni Natzionali Sardu/Guvernu Sardu Provisoriu (MLNS / GSP) acknowledges the fundamental rights of the human being and the freedom of thought, conscience and religion,

considering the Universal Declaration of Human Rights of 10 December 1948,

considering the Convention for the Protection of Human Rights and Fundamental Freedoms of 4 November 1950,

considering that the International Agreements on Economic, Social and Cultural Rights and Civil and Political Rights of 16 December 1966 guarantee the rights of freedom, of conscience and religion without discrimination,

considering the United Nations Declaration of the Rights of Indigenous Peoples, which states, that indigenous peoples are equal to all other peoples, and acknowledges the right of all peoples to be different, to consider themselves different and to be respected as such, and considering that Article. 4 states that, by the exercise of their right of self-determination, these peoples have the right of autonomous self-government, and considering that Article. 7 Section 2 states, that indigenous peoples have the collective right to live in freedom, peace and security as distinct peoples and shall not be subject to any act of genocide or any other act of violence,

considering the dispositions of the Geneva Convention of 12 August 1949 and the preamble of the 1st Protocol, which states that this should be fully applied in all circumstances to all peoples and persons protected by those instruments/rights mentioned above, without any adverse distinction based on the nature or the origin of the conflict, or on the cause pleaded by the parties in conflict, or attributed to them,

considering that Article. 1 point 4 of Protocol I points out, that the situations mentioned include the conflicts and issues, in which peoples are fighting against colonial domination, foreign occupation and against racist regimes by exercising the peoples' right of self-determination, enshrined in the United Nations Charter and the Declaration of principles of international law concerning friendly relations and cooperation among States in accordance with the Charter of Nations,



If and whenever the above should not be capable, the following task will be acquitted by the Fundatzioni Umanidària Natzionali Sarda (F.U.N.S.)


